❖ **Eligibility of Candidates for CAP online Stray Vacancy round:**

1. NEET UG 2025 candidates who have registered but not been allotted a seat till CAP Round - 3 for Group C.

❖ **Non Eligibility for CAP online Stray Vacancy Round :**

1. Candidates who have joined seat in Round 1, Round 2 and/or allotted a seat in CAP Round- 3 for BPTH/BOTH/BASLP/B P&O/BNYS (Group C) courses.
2. Candidates who have joined seat through State Counselling or All India Quota Counselling for MBBS/ BDS/ BAMS/BHMS/BUMS Courses.
3. Candidates who have joined seat in Round 1, Round 2 , Round- 3 & Stray Vacancy Rounds of State Counselling seats for MBBS/BDS/BAMS/BHMS/BUMS Courses.

Note : Online Stray Vacancy Round

1. No new registration will be done for this CAP online Stray Vacancy Round.
2. Candidate will have to fill fresh choices for CAP Online Stray Vacancy. Choice filled during Round 3 will be null and void.
3. It is mandatory to join the seat allotted during Online Stray Vacancy Round(s) hence candidates are advised to be vigilant and fill only those choices where they intend to take admission.
4. Candidates allotted a seat in CAP-3 are not eligible to participate in Online stray round(s) as per the rules mentioned in the Information Brochure.
5. Candidates are advised to verify and ascertain the fee structure from the college website or Fees Regulating Authority website before filling the preference/choice.
6. It is responsibility of the candidates to submit all original documents and necessary fees in the form of DD/Cheque/NEFT/RTGS at the time of admission. Fees can be paid by Cheque only on Holidays to be replaced by DD on next working day.
